A. Liaison Chief's Report

#### Administration – Chief Pearce

The retirement of Barbara Denson has had a domino effect on many aspects of SMEMPS finance and administration. Through the years, SMEMPS has utilized various administrative and finance services from participating member agencies. The City of Mill Valley has served as SMEMPS financial custodian for many years and during this time, SMEMPS has grown into an organization with significant responsibilities in accounting/reporting and sizable financial resources. Following discussions with the City of Mill Valley and the Administrative Chiefs, the consensus was to establish SMEMPS as an independent agency with banking and investment accounts and adequately support these functions with necessary funding.

In the absence of any interested parties taking over these duties, the Tiburon Fire Protection District has agreed to support these functions and implement these services on behalf of SMEMPS. To facilitate these efforts, several Resolutions will be available for Board action later in the meeting.

## **Operations/Training Update - BC Bret McTigue**

RN Educator Bridget Peterson is hosting several ACLS & PALS refresher classes as well as the Train the Trainer 2020 Policy and Procedures update class.

New County Policy and Procedures going into effect on March 1<sup>st</sup> with updates to:

SMEMPS' EMTs and Medics reviewed the updated Plan of Operations for SMEMPS in January.

February EMS training will include the new Narcotic Tracking program PSTRAX and behavioral health services available in Marin for patients.

SMEMPS' resources participated in an Active Shooter and MCI drill at the Discovery Museum in Sausalito on March 9<sup>th</sup>.

## News and Notes:

- PulsePoint app is now available for mobile devices in Marin County. It is designed to provide the public with real-time fire agency incident information and to locate CPR-trained people near someone in cardiac arrest. Marin residents will have access to real-time fire incident information, and local bystanders in Marin can be alerted to administer cardiopulmonary resuscitation (CPR) if needed. When pre-selected, alerts are sent to participating residents only when an emergency occurs in a public place
- The Marin EMS Agency is recruiting for the EMS Administrator position.
   Interviews are being conducted in March
- Coronavirus. Dispatch is prescreening and EMS crews are evaluating any person with flu like symptoms for the virus. Additional PPE precautions are being taken by EMS providers
- The EMS Agency is updating the Multiple Patient Management Plan. The major changes will include field distribution of patients and the coordinating hospital to be changed from Marin Health to Kaiser
- EMS team is preparing for the upcoming Regional academy starting March 30<sup>th</sup>
- The new M6 ambulance is scheduled for delivery and final inspection in .lune
- AMR has been granted a permit to operate BLS, ALS, and CCT units in Marin

- Survivors Celebration is scheduled for May 21<sup>st</sup>
- The old M4 will be received by the Central Marin PD SWAT team for the usage of the transportation of team members
